

ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF BRINDLEY ROAD, RUGBY

Warwickshire County Council proposes to make a Temporary Traffic Order closing Brindley Road, Rugby to vehicular traffic. The closure is required for utility works.

The Order will commence on 24 July 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be in one day on 24 July 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible. An alternative route will be signed and is available via: Brindley Road, School Street, Lower Street, Constable Road (and vice versa).

TEMPORARY CLOSURE OF CHURCH HILL, STRETTON ON DUNSMORE

Warwickshire County Council proposes to make a Temporary Traffic Order closing Church Hill, Stretton on Dunsmore, from the junction with Brookside to the junction Fineacre Lane, to vehicular traffic. The closure is required for drainage & associated works between 08:00 - 17:00 daily.

The Order will commence on 23 July 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 26 July 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible. An alternative route will be signed and is available via: Fineacre Lane, Oxford Road, Freeboard Lane, Plott Lane, School Lane, Brookside and vice versa.

An alternative route will be signed and is available via: Lawford Lane, Main Street, Calvestone Road, Coventry Road (and vice versa).
