ROAD TRAFFIC REGULATION ACT 1984, SECTION 14

TEMPORARY CLOSURE OF KINGS NEWNHAM LANE, KINGS NEWNHAM

Warwickshire County Council proposes to make a Temporary Traffic Order closing Kings Newnham Lane, Kings Newnham, from jct. Kings Newnham Road to jct. Little Lawford Lane, to vehicular traffic. The closure is required for replacement of a telegraph pole.

The Order will commence on 1 August 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 2 August 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible. An alternative route will be signed and is available via: Bretford Road, Kings Newnham Lane, Fosse Way, Newnham Lane (and vice versa).

TEMPORARY CLOSURE OF HALFWAY LANE, RUGBY

Warwickshire County Council has made a Temporary Traffic Order closing Halfway Lane, Rugby from a point outside property number 94, to vehicular traffic. The closure is required for utility works.

The Order will commence on 15 July 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 16 July 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

TEMPORARY CLOSURE OF DYERS LANE, WOLSTON

Warwickshire County Council has made a Temporary Traffic Order closing Dyers Lane, Wolston from the junction of School Street to the junction of Lammas Court to vehicular traffic. The closure is required for gas mains replacement works.

The Order will commence on 15 July 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 2 August 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.
