

ROAD TRAFFIC REGULATION ACT 1984

THE WARWICKSHIRE COUNTY COUNCIL (BACK LANE & BILTON LANE, LONG LAWFORD) (30, 40, & 50 MPH SPEED LIMITS) (VARIATION 1) ORDER 2019

Warwickshire County Council has made the above named Order under the Road Traffic Regulation Act 1984, the effect of which will be to impose a 40 mph speed limit on the length of road mentioned in the Schedule below.

A copy of the Order, together with a plan showing the length of road affected and a statement of the Council's reasons for making the Order, may be inspected at the Main Reception, Shire Hall, Market Place, Warwick, at the Rugby Borough Council, Town Hall, Evreux Way, Rugby CV21 2RR and at the Public Library, Little Elborow St, Rugby CV21 3BZ during usual opening hours. The Order commences on 26 July 2019.

Any person who desires to question the validity of the Order or of any provisions contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order may within six weeks from the date of the making of the Order apply to the High Court for this purpose.

SCHEDULE

(40 mph Speed Limit)

Bilton Lane, Long Lawford

From its junction with the A428 Lawford Road, southwards towards its junction with the A4071 Rugby Western Relief Road.

TEMPORARY CLOSURE OF ANDERSON AVENUE/LONG FURLONG, RUGBY

Warwickshire County Council has made a Temporary Traffic Order closing Anderson Avenue/Long Furlong, Rugby from Fawsley Leys to Kingsway to vehicular traffic. The closure is required for construction of traffic calming measures, 08.00hrs to 17.00hrs weekdays only.

The Order will commence on 27 July 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 30 August 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Orson Leys, Dunchurch Road, Kingsway and vice versa.

TEMPORARY CLOSURE OF WHEATFIELD ROAD, RUGBY

Warwickshire County Council proposes to make a Temporary Traffic Order closing Wheatfield Road, Rugby to vehicular traffic. The closure is required for renewal of a water pipe.

The Order will commence on 12 August 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 13 August 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Blackwood Avenue, Addison Road, Wheatfield Road, Hillfield Road (and vice versa).

TEMPORARY CLOSURE OF KINGS NEWNHAM LANE, KINGS NEWNHAM

Warwickshire County Council has made a Temporary Traffic Order closing Kings Newnham Lane, Kings Newnham, from jct. Kings Newnham Road to jct. Little Lawford Lane, to vehicular traffic. The closure is required for replacement of a telegraph pole.

The Order will commence on 1 August 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 2 August 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Bretford Road, Kings Newnham Lane, Fosse Way, Newnham Lane (and vice versa).

TEMPORARY CLOSURE OF LITTLE LAWFORD LANE, KINGS NEWNHAM

Warwickshire County Council proposes to make a Temporary Traffic Order closing Little Lawford Lane, Kings Newnham, from points approx. 10 metres either side of the bridge, to vehicular traffic. The closure is required for vegetation removal, fencing and coping works.

The Order will commence on 13 August 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed over 3 nights between 22.00hrs to 05.00hrs.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Rugby Road, Harborough Road, Easenhall Road, Little Lawford Lane, Cathiron Lane (and vice versa).
