

## ROAD TRAFFIC REGULATION ACT 1984, SECTION 14

### TEMPORARY CLOSURE OF LITTLE LAWFORD LANE, KINGS NEWNHAM

Warwickshire County Council has made a Temporary Traffic Order closing Little Lawford Lane, Kings Newnham, from points approx. 10 metres either side of the bridge, to vehicular traffic. The closure is required for vegetation removal, fencing and coping works.

The Order will commence on 13 August 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed over 3 nights between 22.00hrs to 05.00hrs.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Rugby Road, Harborough Road, Easenhall Road, Little Lawford Lane, Cathiron Lane (and vice versa).

### TEMPORARY CLOSURE OF WHEATFIELD ROAD, RUGBY

Warwickshire County Council has made a Temporary Traffic Order closing Wheatfield Road, Rugby to vehicular traffic. The closure is required for renewal of a water pipe.

The Order will commence on 12 August 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 13 August 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Blackwood Avenue, Addison Road, Wheatfield Road, Hillfield Road (and vice versa).

### TEMPORARY CLOSURE OF SMITHY LANE, CHURCH LAWFORD

Warwickshire County Council proposes to make a Temporary Traffic Order closing Smithy Lane, Church Lawford from a point outside number 8, to vehicular traffic. The closure is required for works on the undergrounding scheme.

The Order will commence on 27 August 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed in one day on 27 August 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

### TEMPORARY CLOSURE OF GREEN LANE, CHURCH LAWFORD

Warwickshire County Council proposes to make a Temporary Traffic Order closing Green Lane, Church Lawford from a point outside The Old Smithy Pub, to vehicular traffic. The closure is required to facilitate works for a new gas connection.

The Order will commence on 26 August 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 30 August 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

### TEMPORARY CLOSURE OF SMEATON LANE, STRETTON UNDER FOSSE

Warwickshire County Council proposes to make a Temporary Traffic Order closing Smeaton Lane, Stretton under Fosse from junctions with the Fosse way and Colehurst Lane to vehicular traffic. The closure is required for works on and around the bridge.

The Order will commence on 27 August 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed between 9.30 and 15.30 on 27 August 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: B4455, B4027, B4029, Smeaton Lane and vice versa.

### TEMPORARY CLOSURE OF FOSSE WAY, WOLSTON

Warwickshire County Council proposes to make a Temporary Traffic Order closing Fosse Way, Wolston, from junctions with Coventry Road and Rugby Road, to vehicular traffic. The closure is required for works on and around the bridge.

The Order will commence on 28 August 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed between 09.30 and 15.30 on 28 August 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: B4455, A45, A46, A428, B4455 and vice versa.

### TEMPORARY CLOSURE OF PUBLIC FOOTPATH BETWEEN CROWTHORNS AND DERWENT CLOSE, RUGBY

Warwickshire County Council has made a Temporary Traffic Order closing the Public Footpath between Crowthorns and Derwent Close, Rugby, to all traffic. The closure is required to safely facilitate utility works.

The Order will commence on 10 August 2019 and will last for a period of 6 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 16 August 2019.

Access to and egress from properties and land situated adjacent to the length of footpath to be closed will be maintained.
