ROAD TRAFFIC REGULATION ACT 1984, SECTION 14

TEMPORARY CLOSURE OF BIRMINGHAM ROAD (A45/A452 SLIP ROAD) GREAT PACKINGTON

Warwickshire County Council proposes to make a Temporary Traffic Order closing Birmingham Road (A45/A452 Slip Road) Great Packington, to vehicular traffic. The closure is required for the safety of all road users and of the contractors working on or near to the carriageway.

The Order will commence on 3 September 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 6 September 2019.

TEMPORARY CLOSURE OF WHARF LANE, LAPWORTH

Warwickshire County Council proposes to make a Temporary Traffic Order closing Wharf Lane, Lapworth from the junction with Old Warwick Road, to vehicular traffic. The closure is required to safely facilitate access to overhead structures.

The Order will commence on 2 September 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed on 2 September 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Wharf Lane, Old Warwick Road, Stratford Road (and vice versa).

TEMPORARY CLOSURE OF BAKERS LANE, LAPWORTH

Warwickshire County Council has made a Temporary Traffic Order closing Bakers Lane, Lapworth to vehicular traffic. The closure is required for utility works.

The Order will commence on 21 August 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 23 August 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Bakers Lane, Warwick Road, Norton Green Lane, Darley Green Road (and vice versa).
