

ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY 10 MPH SPEED LIMIT – A425 PARK HILL, LOWER SHUCKBURGH

Warwickshire County Council proposes to make a Temporary Traffic Order the effect of which will be to impose a temporary speed limit of 10 mph on the above named road, from a point outside Red Home Farm for a distance of 600 metres in a south easterly direction. The temporary speed limit is required for the safety of all road users and of the contractors working on the carriageway.

PLEASE NOTE: The speed restriction will apply within the convoy working area.

The Order will commence on 10 September 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed between 09.30 and 15.30 on 10 September 2019.

TEMPORARY CLOSURE OF A426 DUNCHURCH ROAD, RUGBY

Warwickshire County Council proposes to make a Temporary Traffic Order closing A426 Dunchurch Road, Rugby, from its jct with Ashlawn Road roundabout to a point outside 296 Dunchurch Road, including the jcts. with Bawnmore Road, Montague Road and Sainsbury's Access Road, to vehicular traffic. The closure is required for carriageway resurfacing & associated works.

PLEASE NOTE: The work will be carried out overnight (Sunday Evening/Monday Morning) on consecutive weekends as follows: 8-9, 15-16 and 22-23 of September 2019 from 19:00pm - 06:00am.

The Order will commence on 8 September 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 23 September 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

TEMPORARY CLOSURE OF FOSSE WAY, WOLSTON

Warwickshire County Council has made a Temporary Traffic Order closing Fosse Way, Wolston, from junctions with Coventry Road and Rugby Road, to vehicular traffic. The closure is required for works on and around the bridge.

The Order will commence on 28 August 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed between 09.30 and 15.30 on 28 August 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

TEMPORARY CLOSURE OF SMEATON LANE, STRETTON UNDER FOSSE

Warwickshire County Council has made a Temporary Traffic Order closing Smeaton Lane, Stretton under Fosse from junctions with the Fosse way and Colehurst Lane to vehicular traffic. The closure is required for works on and around the bridge.

The Order will commence on 27 August 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed between 9.30 and 15.30 on 27 August 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: B4455, B4027, B4029, Smeaton Lane and vice versa.

TEMPORARY CLOSURE OF CASTLE LANE, GRANDBOROUGH

Warwickshire County Council proposes to make a Temporary Traffic Order closing Castle Lane, Grandborough, from a point to the side of Castle Lea to the side of Suttons View, to vehicular traffic. The closure is required for the installation of polyduct.

The Order will commence on 12 September 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 23 September 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Castle Lane, Grandborough Road (and vice versa).

TEMPORARY CLOSURE OF SMITHY LANE, CHURCH LAWFORD

Warwickshire County Council has made a Temporary Traffic Order closing Smithy Lane, Church Lawford from a point outside number 8, to vehicular traffic. The closure is required for works on the undergrounding scheme.

The Order will commence on 27 August 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed in one day on 27 August 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

The Order will commence on 26 August 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 30 August 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.
