

# **ROAD TRAFFIC REGULATION ACT 1984, SECTION 16A SPECIAL EVENTS ORDER – OVO ENERGY TOUR OF BRITAIN 2019**

Warwickshire County Council has made a Special Events Order restricting and prohibiting vehicular traffic on various roads as indicated in the Schedules below:

**PLEASE NOTE: The roads as indicated in the Schedule below will close on 13 September 2019 shortly prior to the event passing through and will reopen once the participants of the Cycling Tour have safely passed.**

## **ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF PUBLIC FOOTPATH R148 RYTON ON DUNSMORE**

Warwickshire County Council made a Temporary Traffic Order closing Public Footpath R148 Ryton on Dunsmore, from the junction of High Street (SP38625 74340) to the footpath on the A45 (SP38771 74354), to all traffic. The closure was required to avoid the likelihood of danger to the public while development works were in progress near to the footpath.

The Order commenced on 11 March 2019 for a period of 6 months, or until the works were completed, whichever was the earlier. However, the Secretary of State in exercise of his powers under Section 15(5) of the Road Traffic Regulation Act 1984 has directed that the Order shall continue in force until 30 June 2020, or until the works to which it relates are completed, whichever is the earlier (unless the Secretary of State issues a further direction).

Access to and egress from properties and land situated adjacent to the length of footpath to be closed, if any, will be maintained where possible.

Please use an alternative route.

## **TEMPORARY CLOSURE OF DAVENTRY ROAD, DUNCHURCH**

Warwickshire County Council proposes to make a Temporary Traffic Order closing Daventry Road, Dunchurch, from the junction with the A426 to the island on A45 (Daventry Road), to vehicular traffic. The closure is required for Carriageway patching and associated works, 09.30 - 15.30 daily.

The Order will commence on 24 September 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 26 September 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Daventry Road, A426, A423, A425, A45.

## **TEMPORARY CLOSURE OF ALLANS LANE, CLIFTON ON DUNSMORE**

Warwickshire County Council proposes to make a Temporary Traffic Order closing Allans Lane, Clifton on Dunsmore, to vehicular traffic. The closure is required to facilitate works for a new water connection. The Order will commence on 24 September 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 26 September 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Allans Lane, Main Street, South Street and vice versa.

## **TEMPORARY CLOSURE OF B4455 BRANDON ROAD/RUGBY ROAD, BRETTFORD**

Warwickshire County Council proposes to make a Temporary Traffic Order closing B4455 Brandon Road/Rugby Road, Bretford, from points either side of Bretford Bridge, to vehicular traffic. The closure is required for utility works over the bridge deck, 9.30 – 15.30 daily.

The Order will commence on 23 September 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 27 September 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Fosse Way, London Road, Coventry Eastern By-Pass, Rugby Road, Brandon Road, Bretford Road, Brandon Road and vice versa.

## **TEMPORARY 10 MPH SPEED LIMIT - A425 PARK HILL, LOWER SHUCKBURGH**

Warwickshire County Council has made a Temporary Traffic Order the effect of which will be to impose a temporary speed limit of 10 mph on the above named road, from a point outside Red Home Farm for a distance of 600 metres in a south easterly direction. The temporary speed limit is required for the safety of all road users and of the contractors working on the carriageway.

**PLEASE NOTE:** The speed restriction will apply within the convoy working area.

The Order will commence on 10 September 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed between 09.30 and 15.30 on 10 September 2019.

## **TEMPORARY CLOSURE OF A426 DUNCHURCH ROAD, RUGBY**

Warwickshire County Council has made a Temporary Traffic Order closing A426 Dunchurch Road, Rugby, from its jct with Ashlawn Road roundabout to a point outside 296 Dunchurch Road, including the jct with Bawmmore Road, Montague Road and Sainsbury's Access Road, to vehicular traffic. The closure is required for carriageway resurfacing & associated works.

**PLEASE NOTE:** The work will be carried out overnight ((Sunday Evening/ Monday Morning)) on consecutive weekends as follows: 8-9, 15-16 and 22-23 of September 2019 from 19:00pm - 06:00am.

The Order will commence on 8 September 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 23 September 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

Alternative routes will be signed and are available via:

1. A426, A428, A4071, A45, Coventry Road, A426 and Vice Versa
2. Bawmmore Road, Overslade Lane and Vice Versa

## **TEMPORARY CLOSURE OF CASTLE LANE, GRANDBOROUGH**

Warwickshire County Council has made a Temporary Traffic Order closing Castle Lane, Grandborough, from a point to the side of Castle Lea to the side of Suttons View, to vehicular traffic. The closure is required for the installation of polyduct.

The Order will commence on 12 September 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 23 September 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Castle Lane, Grandborough Road (and vice versa).

## **TEMPORARY CLOSURE OF BACK LANE, BIRDINGBURY**

Warwickshire County Council proposes to make a Temporary Traffic Order closing Back Lane, Birdingbury to vehicular traffic. The closure is required for sewer connection to the new development. The Order will commence on 23 September 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 27 September 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Back Lane, Leamington Hastings Road, Main Street (and vice versa).
