

**ROAD TRAFFIC REGULATION ACT 1984  
THE WARWICKSHIRE COUNTY COUNCIL  
(RUGBY BOROUGH) (CIVIL ENFORCEMENT  
AREA) (WAITING RESTRICTIONS, ON STREET  
PARKING PLACES AND RESIDENTS' PARKING)  
(CONSOLIDATION) (VARIATION F) ORDER 2019  
THE WARWICKSHIRE COUNTY COUNCIL  
(LONG FURLONG AND ANDERSON AVENUE,  
RUGBY) (20MPH SPEED ZONE) ORDER 2019**

Warwickshire County Council has made the above named Orders under the road Traffic Regulation Act 1984, the effect of which will be:

To restrict waiting as described in the Schedule 1 below;  
To impose a 20 mph zone on the length of roads mentioned in the Schedule 2 below.

These Orders commence on 20 September 2019.

The scheme also includes traffic calming measures and a footway/cycleway track as previously advertised.

A copy of the Orders, together with plans showing the lengths of roads affected and a statement of the Council's reasons for making the Orders may be inspected at the Main Reception, Shire Hall, Market Place, Warwick; The Rugby Library and Information Centre, Little Elborow Street, Rugby CV21 3BZ and at the Rugby Borough Council, Town Hall, Evreux Way Rugby CV21 2RR, during usual opening hours.

Any person who desires to question the validity of the Orders or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of the Act or of any instrument made under it has not been complied with in relation to the Order may within six weeks from the date of the making of the Orders apply to the High Court for this purpose.

**SCHEDULE 1**

**No Waiting At Any Time**

**Rokey School Access Road**

(i) Both sides, from its junction with Long Furlong and Anderson Avenue, southwards for the remainder of its length

**Anderson Avenue**

(i) East side, from its junction with the as yet un-named access road to the Rokey School development, northwards for 32 metres

(ii) West side, from a point opposite the centre line of the as yet un-named access road to the Rokey School development, northwards for 32 metres

**Long Furlong**

(i) South side, from its junction with the as yet un-named access road to the Rokey School development, westwards for 45 metres

(ii) North side, from a point opposite the centre line of the as yet un-named access road to the Rokey School development, westwards for 5 metres

**Dunchurch Road**

(i) North-west side, from its junction with Wentworth Road, south-westwards for 130 metres

(ii) North-west side, from its junction with Wentworth Road, north-eastwards for 5 metres

(iii) South-east side, from its junction with Kingsway, north-eastwards for 35 metres

(iv) South-east side, from its junction with Kingsway, south-westwards for 69 metres

**Wentworth Road**

(i) Both sides, from its junction with Dunchurch Road, north-westwards for 10 metres

**Kingsway**

(i) Both sides, from its junction with Dunchurch Road to a point 13 metres south-east of its junction with Southbrook Road & St Georges Avenue

**Southbrook Road**

(i) Both sides, from its junction with Kingsway, north-eastwards for 10 metres

**St Georges Avenue**

(i) Both sides, from its junction with Kingsway, south-westwards for 10 metres

**No Waiting (Mon - Fri, 8am - 9am & 3pm - 4pm)**

**Long Furlong**

(i) North side, from a point 5 metres west of a point opposite the centre line of its junction with the as yet un-named access road to the Rokey School development, westwards for 18 metres

**20mph Zone**

(i) **Anderson Avenue**; from its junction with Long Furlong, in a generally northerly direction to a point 30 metres north of its junction with Rosewood Avenue

(ii) **Long Furlong**; from its junction with Anderson Avenue, in a generally westerly direction to a point 15 metres west of its junction with Charlesfield Road

**THE WARWICKSHIRE COUNTY COUNCIL  
(ASHLAWN ROAD, RUGBY) (SPEED LIMIT)  
(VARIATION NO. 1) ORDER 2019**

Warwickshire County Council has made the above named Orders under the Road Traffic Regulation Act 1984, the effect of which is to:-

(i) impose a 40 mph speed limit upon that length of Ashlawn Road which is described in Schedule 1 below; and

(ii) vary the existing Warwickshire County Council (Borough of Rugby) (Civil Enforcement Area) (Waiting Restrictions, On-Street Parking Places and Residents' Parking) (Consolidation) Order 2017, as described by approximate measurements) in Schedule 2 below.

The Orders commence on Monday 23 September 2019. Exceptions to any waiting restrictions described in Schedule 2 below will permit waiting for the purposes of picking up and setting down passengers, loading and unloading goods, for vehicles displaying a disabled person's badge and in connection with the maintenance of the road and the supply of gas, water or electricity.

A copy of the Orders, together with a copies of Orders to be varied, plans showing the lengths of road affected and statements of the Council's reasons for making the Orders may be inspected at the Main Reception, Shire Hall, Market Place, Warwick; at Rugby Borough Council, Town Hall, Rugby; and at the Library & Information Centre, Little Elborow Street, Rugby during usual opening hours.

**SCHEDULE 1  
(40mph Speed Limit)**

**Ashlawn Road, Rugby**

From a point 729 metres south-west of its junction with Fareham Avenue, south-westwards to its roundabout junction with Dunchurch Road (being an approximate distance of 2295 metres).

**SCHEDULE 2  
(No Waiting At Any Time)**

**Ashlawn Road, Rugby**

Both sides, from a point 50 metres south-west of the stop line on the north-eastern approach, to a point 50 metres north-east of the stop line on the south-western approach.

**Barby Road, Rugby**

Both sides, from a point 50 metres north-west of the stop line on the south-eastern approach, south-eastwards to its junction with Ashlawn Road.

**Onley Lane, Rugby**

Both sides, from a point 50 metres south-east of the stop line on the north-western approach, north-westwards to its junction with Ashlawn Road.

**ROAD TRAFFIC REGULATION ACT 1984,  
SECTION 14  
TEMPORARY CLOSURE OF BACK LANE,  
BIRDINGBURY**

Warwickshire County Council has made a Temporary Traffic Order closing Back Lane, Birdingbury to vehicular traffic. The closure is required for sewer connection to the new development.

The Order will commence on 23 September 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 27 September 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Back Lane, Leamington Hastings Road, Main Street (and vice versa).

**TEMPORARY CLOSURE OF LAWFORD LANE,  
RUGBY**

Warwickshire County Council proposes to make a Temporary Traffic Order closing Lawford Lane, Rugby to vehicular traffic. The closure is required for the installation of a boundary box and water meter.

The Order will commence on 5 October 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 6 October 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Lawford Lane, Main Street, The Green, Bilton Road, Plexfield Road, Hillfield Road, Wheatfield Road, Nelson Way (and vice versa).

**TEMPORARY CLOSURE OF DAVENTRY ROAD,  
DUNCHURCH**

Warwickshire County Council has made a Temporary Traffic Order closing Daventry Road, Dunchurch, from the junction with the A426 to the island on A45 (Daventry Road), to vehicular traffic. The closure is required for Carriageway patching and associated works, 09.30 - 15.30 daily.

The Order will commence on 24 September 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 26 September 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Daventry Road, A426, A423, A425, A45.

**TEMPORARY CLOSURE OF ALLANS LANE, CLIFTON  
ON DUNSMORE**

Warwickshire County Council has made a Temporary Traffic Order closing Allans Lane, Clifton on Dunsmore, to vehicular traffic. The closure is required to facilitate works for a new water connection.

The Order will commence on 24 September 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 26 September 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Allans Lane, Main Street, South Street and vice versa.

**TEMPORARY CLOSURE OF B4455 BRANDON  
ROAD/RUGBY ROAD, BRETFORD**

Warwickshire County Council has made a Temporary Traffic Order closing B4455 Brandon Road/Rugby Road, Bretford, from points either side of Bretford Bridge, to vehicular traffic. The closure is required for utility works over the bridge deck, 9.30 - 15.30 daily.

The Order will commence on 23 September 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 27 September 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Fosse Way, London Road, Coventry Eastern By-Pass, Rugby Road, Brandon Road, Bretford Road, Brandon Road and vice versa.
