

ROAD TRAFFIC REGULATION ACT 1984 - SECTION 14(1)(a) THE A5 TRUNK ROAD AND THE M1 MOTORWAY (JUNCTION 18) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2019

NOTICE IS HEREBY GIVEN that Highways England Company Limited (Company No. 9346363) has made an Order on the A5 Trunk Road and the M1 Motorway, in the County of Northamptonshire, to allow carriageway repairs and maintenance works to be carried out.

The effect of the Order will be to –

1. Close –

- a) the exit slip road leading from the southbound carriageway of the M1 at Junction 18;
 - b) the entry slip road leading to the southbound carriageway of the M1 at Junction 18; andc) part of the circulatory carriageway of the roundabout
 - junction of the A5 with the A428 and the M1 slip roads (M1 Junction 18 roundabout), that part from the M1 northbound entry slip to the M1 northbound exit slip;

 Prohibit vehicles from entering or leaving the M1 Junction 18
- Prohibit vehicles from entering or leaving the M1 Junction 18 roundabout at its junction with the A428.

The work will be carried out over one night between 22:00 hours and 05:00 hours and is expected to start on Saturday 28 September 2019. The Order will come into force on 23 September 2019.

Vehicles being used for police, fire and rescue authority, ambulance or traffic officer purposes, vehicles being used in connection with the works or for winter maintenance purposes will be exempt from the closure.

A diversion route via the M1 Junction 16, the A45 and the A5 will be signed.
