

ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

COVENTRY ROAD, RUGBY ROAD & FOSSE WAY, BRINKLOW AND COVENTRY ROAD & BRANDON ROAD, WOLSTON

Order Effect: Roads closed to vehicular traffic as follows: Phase 1 – between Heath Lane and Newnham Lane, Phase 2 – between Rugby Road and Limestone Hall Lane.

Reason for Order: To facilitate carriageway resurfacing and associated works, 09.30hrs – 15.30hrs.

Order Commences: 25 November 2019 for 18 months.

Anticipated Completion: 28 November 2019.
