

ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

BLACKWOOD AVENUE, RUGBY

Order Effect: Road closed to vehicular traffic between the two junctions of Collingwood Avenue.

Reason for Order: Carriageway patching and associated works, 9.30hrs – 15.30hrs.

Anticipated Completion: 24 January 2020.
