ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

KINGS NEWNHAM LANE, BRET福德, KINGS NEWNHAM LANE, KINGS NEWMAN ROAD AND LITTLE LAWFORD ROAD, KINGS NEWNHAM, LITTLE LAWFORD LANE, LITTLE LAWFORD AND KINGS NEWNHAM ROAD, CHURCH LAWFORD

Order Effect: Roads closed to vehicular traffic between the junctions of the Fosse Way, School Street and Cathiron Lane.

Reason for Order: Carriageway structural patching and associated works, 08.00hrs - 16.00hrs daily.

Order Commences: 4 March 2020 for up to 18 months.

Anticipated Completion: 5 March 2020.

Access & Diversion: School Street, A428, Queens Street, Fosse Way, Rugby Road, Broad Street, The Crescent, Lutterworth Road, Main Street, Stretton Road, Coventry Road, Rugby Road, Harborough Road and vice versa.

LITTLE LAWFORD LANE, LITTLE LAWFORD

Order Effect: Road closed to vehicular traffic.

Reason for Order: To facilitate a safety examination of the railway bridge.

Order Commences: 1 March 2020 for up to 18 months.

Anticipated Completion: In one day on 1 March 2020.

Access & Diversion: Little Lawford Lane, Harborough Road, Rugby Road, Easenhall Road, Cathiron Lane and vice versa.

Order Effect: Road closed to vehicular traffic.

BALCOMBE ROAD, RUGBY

Order Effect: Road closed to vehicular traffic between the junctions of Charter Road and Fareham Avenue.

Reason for Order: Structural patching of carriageway and associated works.

Order Commences: 16 March 2020 for up to 18 months.

Anticipated Completion: On 16 March 2020 between 09.00hrs and 15.00hrs.

Access & Diversion: Charter Road, Ashlawn Road, Fareham Avenue and vice versa.

MAIN STREET, WILLEY

Order Effect: Road closed to vehicular traffic from its junction with A5 for a distance of approximately 385 metres in a south-westerly direction.

Reason for Order: To safely facilitate the installation of telegraph poles.

Order Commences: 12 March 2020 for up to 18 months.

Anticipated Completion: 13 March 2020.

Access & Diversion: Main Street, Coal Pit Lane, Green Lane, Penn Lane, A5 from end of dualling North West of Wibtoft to start of dualling south of Claybrooke Parva, Watling Street, A5 from start of dualling south of Claybrooke Parva to end of dualling north of Willey Se, from A5 to County Boundary.

For all of the above temporary orders, pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.
