

## ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

### **BULL STREET & CRAVEN LANE, SOUTHAM**

**Order Effect:** Road closed to vehicular traffic.

**Reason for Order:** To facilitate works for the installation of new underground utility equipment.

### **PUBLIC FOOTPATH F1614 FROM SCHOOL HILL TO CHURCH, NAPTON ON THE HILL & ROAD CLOSURE SCHOOL HILL, NAPTON ON THE HILL**

**Orders Effect:** Footpath closed to all traffic. School Hill closed to vehicular traffic from its junction with Chapel Lane to its junction with Hackwell Street/Vicarage Road.

**Reason for Order:** Footpath reconstruction and associated works, drainage investigation, repairs and associated works 08.00hrs-17.00hrs weekdays only.

**Order Commences:** 14 September 2020 for up to 18 months.

**Anticipated Completion:** 17 September 2020.
