ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

LYTHAM ROAD, RUGBY

Order Effect: Road closed to vehicular traffic between the junctions of Overslade Lane and Epsom Road.

PENNINGTON STREET, RUGBY

Order Effect: Road closed to vehicular traffic from a point outside property number 7.

Reason for Order: To facilitate carriageway works to protect sewer beneath.

Access & Diversion: Round Street, Lawford Road, Plowman Street, Pennington Street and vice versa.

Order Effect: Footpath closed to all traffic.

Anticipated Completion: 6 November 2020.

Access & Diversion: Dunchurch Road, Goldsmith Avenue, Norton Leys, Ruskin Close and vice versa.

COTON PARK DRIVE, RUGBY

Order Effect: Road closed to vehicular traffic.

Anticipated Completion: 3 November 2020.

Access & Diversion: Coton Park Drive, Central Park Drive, Leicester Road, Newton Manor Lane and vice versa.
