HILLMORTON LANE AND HOULTON WAY, CLIFTON UPON DUNSMORE, RUGBY SPEED LIMIT VARIATION ORDERS, WAITING RESTRICTIONS AND TRAFFIC

CALMING FEATURE Warwickshire County Council has made the following Orders pursuant to the Road Traffic Regulation Act 1984, the effect of which will be to extend the 30 mph

speed limit as described in Schedule 1 below, and to introduce no waiting at any time restrictions as described (by approximate measurements) in Schedule 2 below:-

1. The Warwickshire County Council (Various Roads, Clifton upon Dunsmore,

Rugby) (30 & 40 mph Speed Limit) (Variation No. 1) Order 2020;

The Warwickshire County Council (Link Road North, Rugby) (30 & 50 mph

Speed Limit) (Variation No. 1) Order 2020; and 3. The Warwickshire County Council (Borough of Rugby) (Civil Enforcement Area) (Waiting Restrictions, On-Street Parking Places and Residents' Parking)

(Consolidation) (Variation H) Order 2020.

The Order commences on Monday, 14th December 2020. Warwickshire County Council will, pursuant to section 90G of the Highways Act

1980, install a centre refuge traffic calming feature on Hillmorton Lane as

described in Schedule 3 below. A copy of the Orders, together copies of Orders to be varied, plans showing the lengths of road affected and a statement of the Council's reasons for making the

the High Court for this purpose. SCHEDULE 1 30 mph Speed Limit

Hillmorton Lane, Clifton upon Dunsmore - 30 mph to be extended (revoking existing 40mph) From a point 80 metres north of the northern shore of the Oxford Canal, in a northerly

direction for a distance of 200 metres.

Houlton Way, Clifton upon Dunsmore — 30 mph (revoking existing 50mph) From the north/south centreline of Hillmorton Lane:-

(I) in a north-westerly direction for a distance of 90 metres; and (II) in a south easterly direction for a distance of 90 metres.

SCHEDULE 2 No Waiting At Any Time

Hillmorton Lane, Clifton upon Dunsmore

From a point 110 metres north of the north shore of the Oxford Canal, in a northerly direction for a distance of 47 metres.
