

ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

BIRDINGBURY ROAD, RUGBY

Order Effect: Road closed to vehicular traffic from a point outside the plot adjacent to The Furrows.

Reason for Order: To enable works for the laying of a new domestic gas service.
