

ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

A428 HILLMORTON ROAD AND ADJOINING ROADS, RUGBY

Order Effect: Roads closed to vehicular traffic in phases as indicated below:

Hillmorton Road closed between its junctions with Catesby Road and Ashlawn Road.

Percival Road, Bowen Road, Langton Road, Stanley Road, Sidney Road, St. Johns Avenue/Fisher Place, Dunsmore Avenue, Shenstone Avenue, Balfour Place, Paddox Close, Rainsbrook Avenue, Walford Place, Kingsley Avenue and Moyeady Avenue closed from their junctions with Hillmorton Road for a distance of between 5-10 metres.

Reason for Order: Carriageway resurfacing and associated works.

While works are in progress the one-way traffic flow in Moyeady Avenue will be temporarily suspended. Access/Egress to Silverdale Gardens and Robbins Court will be restricted whilst works are in progress.
