

ROAD TRAFFIC REGULATION ACT 1984 - SECTION 14(1)(a)**THE A14 TRUNK ROAD (CLAY COTON, WEST NORTHAMPTONSHIRE) (TEMPORARY PROHIBITION OF TRAFFIC IN LAYBY) ORDER 2021**

NOTICE IS HEREBY GIVEN that Highways England Company Limited (Company No. 9346363) has made an order on the A14 Trunk Road, at Clay Coton, in the County of West Northamptonshire, to enable installation of a new sign to be carried out.

The effect of the Order will be to close the layby adjacent to the westbound carriageway of the A14 approximately 1500 metres west of the centreline of Cold Ashby Road overbridge, at Clay Coton.

It is expected that the layby will be closed between 13:00 hours on Thursday 16 September 2021 and 06:00 hours on Friday 17 September 2021. The Order will come into force on 13 September 2021.

Vehicles being used for police, fire and rescue authority or ambulance purposes and vehicles being used in connection with the works will be exempt from the closure.

ROAD TRAFFIC REGULATION ACT 1984 - SECTION 14(1)(a)**THE M1, M45 AND M6 MOTORWAYS (WATFORD GAP MOTORWAY SERVICES AREA TO M1 JUNCTION 19) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2021**

NOTICE IS HEREBY GIVEN that Highways England Company Limited (Company No. 9346363) has made an Order on the M1, the M45 and the M6 Motorways, in the Counties of Leicestershire and West Northamptonshire, to allow routine maintenance works to be carried out.

The effect of the Order will be to close, at different times -

- (1) any slip road leading to or from the M1, to or from Watford Gap motorway service area, south of Junction 17;
- (2) the link road leading to the southbound carriageway of the M1 at Junction 17, from the eastbound carriageway of the M45;
- (3) any slip road leading to or from the M1 at Junction 18;
- (4) the link road leading to the southbound carriageway of the M1 at Junction 19, from the southbound carriageway of the M6;
- (5) any emergency refuge area adjacent to the northbound carriageway of the M1 from its junction with the exit slip road to Watford Gap motorway service area, to its junction with the link road leading from the A14 at Junction 19; and
- (6) any emergency refuge area adjacent to the southbound carriageway of the M1 from its junction with the link road leading to the A14 at Junction 19, to its junction with the entry slip road from Watford Gap motorway service area.

The work will be carried out overnight between 20:00 hours and 06:00 hours and is expected to start on Tuesday 21 September 2021 and continue for eight nights. The Order will come into force on 14 September 2021.

Vehicles being used for police, fire and rescue authority, ambulance or traffic officer purposes, and vehicles being used in connection with the works or for winter maintenance purposes will be exempt from the closures.

Diversion routes via the M6 Junction 1, the A426, the A4303, the M1 Junction 20, M1 Junction 16 and the A45 will be signed. For some closures rolling road blocks will be in operation.

ROAD TRAFFIC REGULATION ACT 1984 - SECTION 14(1)(a)**THE M1 MOTORWAY (JUNCTION 20) (SLIP ROADS) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2021**

NOTICE IS HEREBY GIVEN that Highways England Company Limited (Company No. 9346363) intends to make an Order on the M1 Motorway, in the County of Leicestershire, to enable structural inspection works to be carried out.

The effect of the Order will be to close -

- (1) the exit slip road leading from the northbound carriageway of the M1 at Junction 20; and
- (2) the entry slip road leading to the southbound carriageway of the M1 at Junction 20.

The work will be carried out overnight between 20:00 hours and 06:00 and is expected to start on Tuesday 5 October 2021 and continue for six nights. The Order will come into force on 28 September 2021.

Vehicles being used for police, fire and rescue authority, ambulance or traffic officer purposes and vehicles being used in connection with the works or for winter maintenance purposes will be exempt from the closures.

A diversion route via the M1 Junction 21 will be signed.

ROAD TRAFFIC REGULATION ACT 1984 - SECTION 14(1)(a)**THE A45 AND A423 TRUNK ROADS (TOLLBAR END TO RYTON-ON-DUNSMORE, WARWICKSHIRE) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2021**

NOTICE IS HEREBY GIVEN that Highways England Company Limited (Company No. 9346363) intends to make an Order on the A45 and A423 Trunk Roads, between Tollbar End and Ryton-on-Dunsmore, in the City of Coventry and the County of Warwickshire, to allow resurfacing, stud replacement, road markings and maintenance works to be carried out.

The effect of the Order will be to, at different times -

- (1) close the eastbound carriageway of the A45 from its roundabout junction with the A46, the B4110 and Rowley Road (Tollbar End Roundabout), at Tollbar End, to its roundabout junction with the A445 and Warwick Road (Ryton Roundabout), at Ryton-on-Dunsmore;
- (2) close the westbound carriageway of the A45 from its junction with Ryton Roundabout, to its junction with the entry slip road leading from the roundabout junction with the A423 and Hillman Road, at Ryton-on-Dunsmore (the A423 Roundabout);
- (3) close the circulatory carriageway of the A423 Roundabout;
- (4) close any slip road leading to or from the A45, to or from the A423 Roundabout; and
- (5) prohibit vehicles from entering or leaving the lengths of the A45 described in (1) and (2) above at the junction with any side road.

The work will be carried out in phases and is expected to start on Saturday 2 October 2021 and continue for three weekends. The carriageway, slip road closures and prohibition will be in operation from 00:01 hours to 06:00 hours on Saturday and from 21:00 hours to 23:59 hours on Sunday. The roundabout closure will be in operation from 04:00 on Saturday to 21:00 hours on Sunday. The Order will come into force on 27 September 2021.

Vehicles being used by police, fire and rescue authority or ambulance purposes, and vehicles being used in connection with the works or for winter maintenance purposes will be exempt from the closures and prohibition. Access to properties will be maintained at all times.

Diversion routes via alternative junctions of the A45 and the A423 and via the A46, the A452, Lillington Avenue, Lillington Road and the A445 and vice versa will be signed.
