

ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

PUBLIC FOOTPATHS F10780 BETWEEN COVENTRY STREET & WELSH ROAD AND F22150 FROM LITTLE PARKS FOOTPATHS, SOUTHAM

Order Effect: Public Footpaths F10780 between Coventry Street & Welsh Road closed to ALL traffic from Coventry Street to a point adjacent to the builders' yard and F22150 Little Parks Footpaths closed along its entire length from Little Park to F10780.

Reason for Order: To enable works for the installation of street lighting.

Order Commences: 1 November 2021 for up to 6 months.

Anticipated Completion: 5 November 2021.

Access & Diversion: Little Park, Park Lane, Market Hill, High Street, Coventry Street, Welsh Road West and vice versa.

C36 BYFIELD ROAD, PRIORS MARSTON

Order Effect: Road closed to vehicular traffic from its junction with Hardwick Road to entrance of Priors Marston Sports and Social Club.

Reason for Order: Drainage and associated works, 09.30hrs-15.30hrs.

Order Commences: 18 November 2021 for up to 18 months.

Anticipated Completion: 19 November 2021.

Access & Diversion: Main Road, Hellidon Road, A361, Boddington Road, Byfield Road and vice versa.

D2310 HOWCOMBE LANE, NAPTON ON THE HILL

Order Effect: Road closed to vehicular traffic between its junctions with New Street/Chapel Green Road and Poplar Road.

Reason for Order: Carriageway patching and associated works, 09.00hrs-15.30hrs.

Order Commences: 16 November 2021 for up to 18 months.

Anticipated Completion: 18 November 2021.

Access & Diversion: Poplar Road, The Butts, School Hill, Hackwell Street, High Street, New Street and vice versa.

For all of the above temporary orders, pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

THE WARWICKSHIRE COUNTY COUNCIL (THE TRUNK ROAD (A423) (COVENTRY ROAD, SOUTHAM)) (RESTRICTED ROAD) (REVOCATION) ORDER 2021

Warwickshire County Council has made the above-named Order under the Road Traffic Regulation Act 1984, the effect of which revokes an existing Restricted Roads Order on the length of road described in the Schedule below, as that length of road has become a restricted road by virtue of a system of street lighting now in place thereon.

The Order commences on 1st November 2021.

Any person who desires to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order may within six weeks from the date of the making of the Order apply to the High Court for this purpose.

Coventry Road, Southam (A423)

From a point 197 metres north of its junction with Welsh Road West, to a point 466 metres north of that junction (a distance measured along the said length of road of 269 metres).
