ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

ALEXANDRA ROAD, RUGBY

Order Effect: The One-way traffic flow on Alexandra Road will be temporarily suspended.

Reason for Order: To allow access/egress to residents because of nearby gas works.

Order Commences: 14 March 2022 for up to 18 months.

Anticipated Completion: 1 April 2022.

Order Effect: Road closed to vehicular traffic between the junctions of Bilton Road and Addison Road.

Anticipated Completion: 31 March 2022.

Access & Diversion: Bilton Road, Addison Road and vice versa. Access to Grace Close may be affected while works are in progress.

For all of the above temporary orders, pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.
