THE A5 TRUNK ROAD (NORTHEAST OF
CHURCHOVER, WARWICKSHIRE)
(TEMPORARY PROHIBITION OF
TRAFFIC IN LAYBY) ORDER 2022**

NOTICE IS HEREBY GIVEN that National Highways Limited (Company No. 9346363) intends to make an order on the A5 Trunk Road, northeast of Churchover, in the County of Warwickshire, to allow renewal of weather monitoring equipment to be carried out.

The effect of the Order will be to close the layby situated adjacent to the southbound carriageway of the A5 approximately 1.5 kilometres south of the centrepoint of roundabout junction with the A4303, Coal Pit Lane and the B4027 Lutterworth Road.

The layby is expected to be closed between 20:00 hours on Monday 16 May 2022 and 06:00 hours on Wednesday 1 June 2022. The Order will come into force on 13 May 2022.

Vehicles being used for police, fire and rescue authority or ambulance purposes, and vehicles being used in connection with the works will be exempt from the closure.

THE A5 TRUNK ROAD (CRICK
TO LILBOURNE) (TEMPORARY
RESTRICTION OF TRAFFIC) ORDER 2022**

NOTICE IS HEREBY GIVEN that National Highways Limited (Company No. 9346363) has made an Order on the A5 Trunk Road, in the Counties of West Northamptonshire and Warwickshire, to enable a new roundabout to be constructed.

The effect of the Order will be to impose a 40 miles per hour speed restriction on the A5 between its roundabout junction with Danes Way at Crick and the centreline of its junction with Hillmorton Lane, near Lilbourne.

It is expected that the speed limit will be in operation 24 hours a day from 00:01 hours on Thursday 5 May 2022 for approximately four months. The Order will come into force on 2 May 2022.

Vehicles being used for police, fire and rescue authority, ambulance and special forces purposes will be exempt from the speed restriction.
