

ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

BURNTHURST LANE, PRINCETHORPE

Order Effect: Road closed to vehicular traffic from a point outside Hazel House to the junction with Nunwood Lane.

Reason for Order: To enable works to locate and clear blockages in pipes/ducts.

BIRDINGBURY ROAD/FRANKTON ROAD, BIRDINGBURY
