

ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

A423 OXFORD ROAD, MARTON

Order Effect: Road closed to vehicular traffic between its junctions with Birdingbury Road and Shakers Lane.

Reason for Order: Carriageway patching and associated works, 09.30hrs-15.30hrs.

Order Commences: 20 December 2022 for up to 18 months.

Anticipated Completion: 20 December 2022.

Access & Diversion: A423, A426, Coventry Road, A45, A445, A423 and vice versa.

OXFORD STREET, RUGBY

Order Effect: Road closed from the junction with Abbey Street/Cross Street to the junction with Argyle Street.

Reason for Order: To safely facilitate multiple trial holes.

Anticipated Completion: 22 December 2022.

Access & Diversion: Oxford Street, Cross Street, Cambridge Street, Clifton Road and vice versa.

ROUNDS GARDENS, RUGBY

Order Effect: Road closed to ALL traffic between its junctions with Oliver Street and Edward Street.

Reason for Order: Demolition, redevelopment and associated works.

Order Commences: 21 December 2022 and will continue in force until the works are completed.

Access & Diversion: There will be no access for traffic from the Oliver Street junction with Round Gardens. Access/egress to/from Blackman Way, Levy Close and Carolyn Court may be affected while works are in progress. Access via Round Gardens for Blackman Way, Levy Close and Carolyn Court will be maintained as site safety and works permit.

Order Effect: Footpaths closed to ALL traffic as follows: R117/2 from Grid Ref SP45731,75828 to 45739,75912, R117/5 from Grid Ref SP15739,75912 to 45737, 75971 and R117a/1 from Grid Ref SP45739,75912 to 45786,75935.

Reason for Order: For the safety of the public whilst structural repairs are carried out on the railway structure under which the footpaths pass.

Order Commences: 3 January 2023 for up to 6 months.

Anticipated Completion: 16 June 2022.

Access & Diversion: R117, R117b, Church Road, R119 & Rugby Road.

A428 LAWFORD ROAD, RUGBY

Order Effect: Road closed to vehicular traffic between the junctions of Corporation Street and Torrance Avenue.

Reason for Order: To safely enable carriageway resurfacing and associated works.

Anticipated Completion: 12 March 2023.

Access & Diversion: A428, A4071, A45, Coventry Road, A426, and vice versa.

For all of the above temporary orders, pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.
