ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

B4455 FOSSE WAY, STRETTON ON DUNSMORE

Order Effect: Road closed to vehicular traffic between its junctions with Knob Hill (nr Frankton Lane) and Fosse Crescent.

Reason for Order: Carriageway resurfacing and associated works, overnight 20.00hrs-06.00hrs weeknights only excluding Bank Holiday Monday.

Order Commences: 26 April 2023 for up to 18 months.

Anticipated Completion: 6 May 2023.

Access & Diversion: B4455 Fosse Way, A423, A445, A45, B4455 Fosse Way and vice versa.

Warwickshire County Council proposes to make the following Temporary Traffic Orders:

BRINDLEY ROAD, RUGBY

Order Effect: Road closed to vehicular traffic.

Reason for Order: To safely enable structural examination of the railway bridge. Road closed 09.30hrs-15.30hrs.

Order Commences: 8 May 2023 for up to 18 months.

Anticipated Completion: 8 May 2023.

Access & Diversion: No diversion possible.

HINCKLEY ROAD & LUTTERWORTH ROAD, WOLVEY

Order Effect: Roads closed to vehicular traffic as follows:

Hinckley Road – The Southbound Lane from the jct with Lutterworth Road, northerly for 130m.

Lutterworth Road – The Eastbound Lane from its jct. with Hinckley Road easterly for 75m.

Reason for Order: To enable phase 3 works for the construction of a roundabout.

Order Commences: 8 May 2023 for up to 18 months.

Anticipated Completion: 29 May 2023.

Access & Diversion: Hinckley Road, Gipsy Lane, Lutterworth Road.

MAIN STREET, FRANKTON, RUGBY

Order Effect: Road closed to vehicular traffic between its junction with Birdingbury Lane.

Reason for Order: To safely enable works on urgent water quality mains renewal scheme.

Order Commences: 8 May 2023 for up to 18 months.

Anticipated Completion: 16 May 2023.

Access & Diversion: Birdingbury Road, Bourton Lane, Main Street, Frankton Road, Bourton Road and vice versa.

LANCASTER ROAD, RUGBY

Order Effect: Road closed between junctions of A426 Newbold Road and Park Road.

Reason for Order: To enable mains laying, installation of services & connections, backfill, reinstatement and clearance of site.

Order Commences: 8 May 2023 for up to 18 months.

Anticipated Completion: 1 June 2023.

Access & Diversion: Park Road, Evreux Way, Newbold Road and vice versa. No works on 6 May 2023 and 21 May 2023 due to local events.
