It runs generally west-northwest for 6531). approximately 350 metres to a point labelled B (grid reference SP5229 - 6533), then generally northnorthwest for approximately 50 metres to a point labelled C (grid reference SP5227 - 6537), then generally west north-west for approximately 790 metres to a point labelled D (grid reference SP5154 - 6571) and then generally west north-west for approximately 670 metres to a point labelled E (grid reference SP5089 - 6577), continues generally west north-west for approximately 220 metres to a point labelled F (grid reference SP5068 - 6587) and then generally north for approximately 50 metres to point G (grid reference SP5067 - 6592) the generally west north-west for approximately 28 metres to junction D2289 Wolfhampcote Lane labelled point H (grid

reference SP5065 – 6592).
The width of the route is 12.192 metres (40 foot). The route is unsurfaced.
