

ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

BACK LANE, BILTON LANE, COVENTRY ROAD & RUGBY ROAD, LONG LAWFORD

Order Effect: Roads closed to vehicular traffic as follows: **Back Lane** – From its junction with Coventry Road for 50m northerly direction, **Bilton Lane** – From its junction with Coventry Road for 10m southerly direction, Coventry Road & Rugby Road – From a point 150m West of junction with Bilton Lane to a point 60m East of junction with Bilton Lane.

Reason for Order: To enable remedial works to newly constructed road.

Order Commences: 20 May 2024 for up to 18 months.

Anticipated Completion: 24 May 2024.
