ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF B4439 OLD WARWICK ROAD, LAPWORTH

Warwickshire County Council has made a Temporary Traffic Order closing B4439 Old Warwick Road, Lapworth from a point outside the property known as Lilac Cottage to a point outside the timber yard, to vehicular traffic.

The closure is required to facilitate surface dressing works between 07.00hrs and 17.00hrs daily.

The Order will commence on 5 August 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 7 August 2017.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: B4439 Old Warwick Road, A4177 Birmingham Road, A4141 Birmingham Road, A4141 Warwick Road, B4101 Station Road, B4101 Grange Road, B4101 Aylesbury Road, A3400 Stratford Road B4439 Old Warwick Road and vice versa.

TEMPORARY CLOSURE OF PUBLIC FOOTPATH SL46 IN THE PARISH OF LAPWORTH

Warwickshire County Council has made a Temporary Traffic Order closing Public Footpath SL46 in the Parish of Lapworth at Grid Reference SP15951-73394 to vehicular traffic.

The closure is required for public safety because of the dilapidated and dangerous condition of a bridge along its route.

The Order will commence on 9 August 2017 and will last until remedial works are completed, or until 17 January 2018 whichever is the earlier.

Pedestrian access to and egress from properties and land situated adjacent to the length of footpath to be closed, if any, will be maintained at all times.

An alternative route will be signed and is available via: Grange Road and Aylesbury Road.

TEMPORARY CLOSURE OF RISING LANE, LAPWORTH

Warwickshire County Council proposes to make a Temporary Traffic Order closing Rising Lane, Lapworth to vehicular traffic.

The closure is required to facilitate works for the connection of new plots to the water main.

The Order will commence on 21 August 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier.

Please note: The work is being carried out in two phases as follows:

Phase 1 - 21 August 2017 with anticipated completion by 23 August 2017

Phase 2 - 30 August 2017 with anticipated completion by 1 September 2017

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Birmingham Road, Warwick Road (from H/street To Chadwick End), Bakers Lane, Chapel Lane, Chessetts Wood Road, Rising Lane (and vice versa).
