

ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF LAPWORTH STREET, LAPWORTH

Warwickshire County Council proposes to make a Temporary Traffic Order closing Lapworth Street, Lapworth to vehicular traffic.

The closure is required to safely facilitate works on overhead cables.

The Order will commence on 23 October 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 25 October 2017.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Old Warwick Road, Packwood Lane, Stratford Road Aylesbury Road to Boundary (2326-2679), Stratford Road, M40 junction 16 To M42 junction 3a, Bushwood Lane, Lapworth Street (and vice versa).

TEMPORARY CLOSURE OF SPRING LANE, LAPWORTH

Warwickshire County Council proposes to make a Temporary Traffic Order closing Spring Lane, Lapworth to vehicular traffic.

The closure is required to facilitate replacement of overhead line poles and reconductor

The Order will commence on 23 October 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 27 October 2017.

Please note: The work will be carried out from 8.30hrs to 16.30hrs daily between the above dates.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Spring Lane, Wharf Lane, Old Warwick Road, Church Lane (and vice versa).

TEMPORARY CLOSURE OF D5048 TAPSTER LANE, LAPWORTH

Warwickshire County Council has made a Temporary Traffic Order closing D5048 Tapster Lane, Lapworth from Bushwood Lane Northbound to the junction of Yew Tree Lane, to vehicular traffic.

The closure is required to facilitate carriageway resurfacing works.

The Order will commence on 9 October 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 13 October 2017.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Bushwood Lane, Wheatsheaf Lane, Hole House Lane, Tapster Lane, Yew Tree Lane, Lapworth Street and Vice Versa.

TEMPORARY CLOSURE OF C137 DYRES LANE, HOCKLEY HEATH

Warwickshire County Council proposes to make a Temporary Traffic Order closing C137 Dyres Lane, Hockley Heath from the junction of Cut Throat Lane to the Canal Bridge, to vehicular traffic.

The closure is required to facilitate edge strengthening & ditch cleaning works and for the installation of new drainage.

The Order will commence on 23 October 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 16 November 2017, weather permitting.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Dyers Lane, Illshaw Heath Road, Warings Green Road, Cut Throat Lane and vice versa.
