ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF TOM HILL, TANWORTH IN ARDEN

Warwickshire County Council proposes to make a Temporary Traffic Order closing Tom Hill, Tanworth in Arden between Broad Lane and the property known as Yew Tree Cottage, to vehicular traffic.

The closure is required to facilitate works for LV line reconductoring.

The Order will commence on 29 March 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed in one day on 29 March 2018.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Tom Hill, Broad Lane, Alcester Road, Alderhanger Lane Layby, Tanworth Lane, Alderhanger Lane, Bates Lane, The Green, Doctors Hill (and vice versa).

TEMPORARY CLOSURE OF C90 UMBERSLADE ROAD & C89 LEAFY LANE, EARLSWOOD

Warwickshire County Council has made a Temporary Traffic Order closing C90 Umberslade Road & C89 Leafy Lane, Earlswood at their junction with each other, to vehicular traffic.

The closure is required to facilitate carriageway patching works.

The Order will commence on 12 March 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed in one day on 12 March 2018.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Umberslade Road, Earlswood Common, Broad Lane, Tithe Barn Lane and vice versa.
