

ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF BATES LANE, TANWORTH IN ARDEN

Warwickshire County Council has made a Temporary Traffic Order closing Bates Lane, Tanworth in Arden from the junction with Vicarage Hill to the junction with Blind Lane, to vehicular traffic.

The closure is required to facilitate works for the installation of a duct.

The Order will commence on 30 March 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 7 April 2018.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Blind Lane, Broad Lane, Vicarage Hill, Bates Lane (and vice versa).

TEMPORARY 10 MPH SPEED LIMIT – SOUTH WARWICKSHIRE SURFACE DRESSING 2018

Warwickshire County Council has made a Temporary Traffic Order the effect of which will be to impose a temporary speed limit of 10 mph on the roads as indicated in the schedule below.

Lengths of Road to be Subject to Temporary 10mph Speed Limit	Parish	From	To
C105 Penn Lane	Tanworth in Arden	Surface change east of Woodcock Close	A435 overbridge
D5005 Wood End Lane	Tanworth in Arden	Broad Lane	End

The temporary speed limit is required for the safety of all road users and of the contractors working on the carriageway.

The Order will commence on 1 April 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 30 September 2018.

Please Note: The speed restriction will only be imposed whilst convoy work for surface dressing is being carried out to each road – advance signage will be in place as appropriate.

TEMPORARY CLOSURE OF LAPWORTH STREET, LAPWORTH

Warwickshire County Council has made a Temporary Traffic Order closing Lapworth Street, Lapworth from a point approximately 101 metres north west to a point 10 metres south of the junction with Dicks Lane, to vehicular traffic.

The closure is required to safely facilitate works for the installation of a duct in the verge.

The Order will commence on 5 April 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 8 May 2018.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Lapworth Street, Old Warwick Road, Finwood Road, Mill Lane (and vice versa).
