## **ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF GROVE LANE, LAPWORTH**

Warwickshire County Council proposes to make a Temporary Traffic Order closing Grove Lane, Lapworth from B4439 Old Warwick Road to Packwood Road, to vehicular traffic.

The closure is required to facilitate utility works.

The Order will commence on 19 June 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 21 June 2018.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Grove Lane, Packwood Lane, Old Warwick Road (and vice versa).

## **TEMPORARY CLOSURE OF RAMSHILL LANE, DEANS GREEN**

Warwickshire County Council proposes to make a Temporary Traffic Order closing Ramshill Lane, Deans Green for a distance of approximately 20 metres either side of the railway bridge, to vehicular traffic.

The closure is required to facilitate works for a safety examination of the bridge structure.

The Order will commence on 20 June 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed in one day on 20 June 2018.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Ramshill Lane, Gentlemans Lane, Forde Hall Lane, Bates Lane, The Green, Well Lane, Danzey Green Lane (and vice versa).

## **TEMPORARY CLOSURE OF CHURCH LANE, LAPWORTH**

Warwickshire County Council has made a Temporary Traffic Order closing Church Lane, Lapworth from a point outside the property known as The Rectory, to vehicular traffic.

The closure is required to safely facilitate works for the installation of a duct in the verge.

The Order will commence on 1 June 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 5 June 2018.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Church Lane, Spring Lane, Wharf Lane, Old Warwick Road (and vice versa).
