

## **ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF PIG TROT LANE, TANWORTH IN ARDEN**

Warwickshire County Council proposes to make a Temporary Traffic Order closing Pig Trot Lane, Tanworth in Arden from a point approximately 220 metres from Dingle House Farm, to vehicular traffic.

The closure is required to safely facilitate works for the installation of a duct in the verge.

The Order will commence on 5 November 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 7 November 2018.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Pig Trot Lane, Danzey Green Lane, Mill Lane, Tanworth Lane, Birmingham Road, Liveridge Hill, Nuthurst Road, Nuthurst Lane, Kemps Green Road (and vice versa).

## **TEMPORARY CLOSURE OF OUTWOODS LANE, GREAT PACKINGTON**
