

ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF C20 POOLHEAD LANE & D5003 FORSHAW HEATH ROAD, EARLSWOOD

Warwickshire County Council proposes to make a Temporary Traffic Order closing C20 Poolhead Lane & D5003 Forshaw Heath Road, Earlswood from the junction with D5002 Forshaw Heath Road to the County Boundary, to vehicular traffic.

PLEASE NOTE: Access to Mill Lane from Forshaw Heath Road will be restricted during the closure.

The closure is required to facilitate works for carriageway resurfacing and edge strengthening.

The Order will commence on 7 January 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 1 February 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Forshaw Heath Road, Rumbush Lane, Norton Lane, Station Road, A435 Alcester Road, Forshaw Heath Road (locally known as Forshaw Heath Lane) and vice versa.

TEMPORARY CLOSURE OF D5045 GROVE LANE, LAPWORTH

Warwickshire County Council proposes to make a Temporary Traffic Order closing D5045 Grove Lane, Lapworth from its junction with Packwood Lane to its junction with the B4439 Old Warwick Road, to vehicular traffic.

The closure is required to facilitate carriageway structural patching works.

The Order will commence on 10 January 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed between 08.00hrs and 16.00hrs in one day on 10 January 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: B4439 Old Warwick Road, Packwood Lane and vice versa.
