

# **SOLIHULL METROPOLITAN BOROUGH COUNCIL**

## **The Metropolitan Borough of Solihull (Colebrook Road, Shirley) (Temporary Road Closure) Order 2018**

The Council gives notice that it intends to make the above Order under Sections 14 and 15 of the Road Traffic Regulation Act 1984 (as amended by the Road Traffic (Temporary Restrictions) Act 1991) to allow railway infrastructure works to be undertaken. Colebrook Road, Shirley will be closed either side of the railway bridge from Monday 14th January to Friday 25th January 2019 (2200hrs to 0600hrs each night – weekdays only). Alternative routes signed via Colebrook Road, Haslucks Green Road, Green Lane and Aqueduct Road. Vice versa for the other direction. Access for emergency services will be maintained. ## **The Metropolitan Borough of Solihull (Burtons Way, Smith's Wood) (Restricted Parking Zone and Disabled Parking Bays) Order 2018**

The Council has made this Order under the Road Traffic Regulation Act 1984 as amended, and all other enabling powers. The reasons for this Order can be obtained by written request from the address below; or by inspecting the documents at Solihull Connect, Library Square, Touchwood, Solihull during normal opening hours or via [www.solihull.gov.uk/Resident/Parking-travel-roads/roadworks-and-restrictions/tros](http://www.solihull.gov.uk/Resident/Parking-travel-roads/roadworks-and-restrictions/tros) A copy of the Order is available upon request. Anyone wishing to question the validity or provisions of the Order should apply to the High Court within six weeks from the date that the Order became effective. The Order, which comes into force on 14 January 2019, will introduce the following: Restricted Parking Zone (No Waiting Except in Signed Bays) Access Road to Smith's Wood Medical Centre – from a point 17m east of Burtons Way in an easterly direction, to its cul-de-sac end (a distance of approximately 26m). Disabled Parking Bays (Parking Limited to 3 Hours for Disabled Blue Badge Holders Only) Access Road to Smith's Wood Medical Centre – two marked disabled bays in the cul-de-sac end of the Access Road (indicated on the order plan). Revocation of Disabled Parking Bays Access Road to Smith's Wood Medical Centre – the two marked disabled bays west of the access to Smiths Wood Medical Centre (indicated on the order plan).
