

ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF C23 RISING LANE, BADDESLEY CLINTON

Warwickshire County Council has made a Temporary Traffic Order closing C23 Rising Lane, Baddesley Clinton from its junction with Netherwood Lane to its junction with Station Lane, to vehicular traffic.

The closure is required to facilitate drainage works

PLEASE NOTE: It is anticipated that works will be carried out between 09.30hrs and 15.30hrs weekdays only and the road will be open outside of these hours.

The Order will commence on 21 January 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 1 February 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Rising Lane, Packwood Lane, Old Warwick Road, Finwood Road, Rowington Green, Finwood Road, Haywood Lane, Rising Lane and vice versa.

TEMPORARY CLOSURE OF D5034 BAKERS LANE, LAPWORTH

Warwickshire County Council has made a Temporary Traffic Order closing D5034 Bakers Lane, Lapworth from its junction with Chapel Lane to the County boundary, to vehicular traffic.

The closure is required to facilitate carriageway patching works.

The Order will commence on 21 January 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 23 January 2019.

PLEASE NOTE: The works will be carried out between 08.00hrs and 16.00hrs daily and the road will be open for use outside of these times.
