

ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF C137 TOM HILL & D5022 PIG TROT LANE, TANWORTH IN ARDEN

Warwickshire County Council proposes to make a Temporary Traffic Order closing C137 Tom Hill & D5022 Pig Trot Lane, Tanworth in Arden to vehicular traffic as indicated below.

D5022 Pig Trot Lane	from its junction with Kemps Green Road to its junction with Danzey Green Lane	21-22 February 2019 08.00hrs to 17.00hrs	Umberslade Road, Broad Lane, Tom Hill, Butts Lane, Danzey Green Lane and vice versa

The closures are required to facilitate drainage works.

The Order will commence on 18 February 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 22 February 2019.

PLEASE NOTE: It is anticipated that the road will re-open outside of the hours indicated above.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

TEMPORARY CLOSURE OF D5050 HOLE HOUSE LANE, LAPWORTH

Warwickshire County Council has made a Temporary Traffic Order closing D5050 Hole House Lane, Lapworth, from its junction with Tapster Lane to its junction with Wheatsheaf Lane, to vehicular traffic.

The closure is required to facilitate drainage works

The Order will commence on 4 February 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 15 February 2019, weather permitting.

PLEASE NOTE: It is anticipated that works will be carried out between 08.00hrs and 17.00hrs weekdays only and the road will be open outside of these hours.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Tapster Lane, Bushwood Lane, Wheatsheaf Lane and vice versa.
