## **ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF ALDERHANGER LANE, TANWORTH IN ARDEN**

Warwickshire County Council proposes to make a Temporary Traffic Order closing Alderhanger Lane, Tanworth in Arden to vehicular traffic.

The closure is required to facilitate works to repair a water pipe.

The Order will commence on 27 February 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 1 March 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Alderhanger Lane, Blind Lane, Broad Lane, Alcester Road, Alderhanger Lane Layby, Gorcott Hill, Ullenhall Lane, Beoley Lane, Tanworth Lane (and vice versa).

## **TEMPORARY CLOSURE OF CHESSETTS WOOD ROAD, LAPWORTH**

Warwickshire County Council has made a Temporary Traffic Order closing Chassetts Wood Road, Lapworth from a point outside property number 93, to vehicular traffic.

The closure is required to facilitate excavation works to enable new water plots connection to the mains.

The Order will commence on 11 February 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 13 February 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Chassetts Wood Road, Rising Lane, Packwood Lane, Packwood Road (and vice versa).
