

ROAD TRAFFIC REGULATION ACT 1984, SECTION 14

TEMPORARY CLOSURE OF PUBLIC FOOTPATH SD267A IN THE PARISH OF TANWORTH IN ARDEN

Warwickshire County Council has made a Temporary Traffic Order closing Public Footpath SD267a in the Parish of Tanworth in Arden, at grid references SP10217-70350, to all traffic.

The closure is required to avoid the likelihood of danger to the public as the result of the dilapidated and dangerous condition of a bridge along its route.

The Order will commence on 22 February 2019 and will last for a period of 6 months, or until remedial works are completed, whichever is the earlier.

Access to and egress from properties and land situated adjacent to the length of footpath to be closed will be maintained where possible.

An alternative route will be signed and is available via: Aspley Heath Road and Blind Lane.

TEMPORARY CLOSURE OF PUBLIC FOOTPATH SD267 IN THE PARISH OF TANWORTH IN ARDEN

The Order will commence on 23 February 2019 and will last for a period of 6 months, or until remedial works are completed, whichever is the earlier.

Access to and egress from properties and land situated adjacent to the length of footpath to be closed, if any, will be maintained.

An alternative route will be signed and is available via: Aspley Heath Road, Blind Lane and Public footpath SD267a.

TEMPORARY CLOSURE OF DANZEY GREEN LANE, TANWORTH IN ARDEN

Warwickshire County Council proposes to make a Temporary Traffic Order closing Danzey Green Lane, Tanworth in Arden to vehicular traffic.

The closure is required to safely facilitate tree cutting works to clear overhead electricity cables.

The Order will commence on 13 March 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed in one day on 13 March 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Danzey Green Lane, Well Lane, The Green, Vicarage Hill, Broad Lane, Pound House Lane, Spring Lane, Stratford Road, Aylesbury Road to County Boundary (2326-2679), Stratford Road, Liveridge Hill, Birmingham Road, Tanworth Lane, Mill Lane (and vice versa).

TEMPORARY CLOSURE OF ALDERHANGER LANE, TANWORTH IN ARDEN

Warwickshire County Council has made a Temporary Traffic Order closing Alderhanger Lane, Tanworth in Arden to vehicular traffic.
