

## ROAD TRAFFIC REGULATION ACT 1984 - SECTION 14(1)(a) THE M42 (JUNCTION 4 TO JUNCTION 5) (SLIP ROADS) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2019

NOTICE IS HEREBY GIVEN that Highways England Company Limited (Company No. 9346363) intends to make an Order on the M42 Motorway, in the Metropolitan Borough of Solihull, to allow vegetation and maintenance works to be carried out.

The effect of the Order will be to close –

- (1) the exit slip road leading from the northbound carriageway of the M42 at Junction 4; and(2) the entry slip road leading to the northbound carriageway of
- (2) the entry slip road leading to the northbound carriageway of the M42 at Junction 5.
  The work will be carried out overnight between 21:00 hours and 06:00

hours and is expected to start on Friday 22 March 2019 and continue for four nights. The Order will come into force on 15 March 2019, Vehicles being used for police, fire and rescue authority, ambulance or traffic officer purposes and vehicles being used in connection with the works or for winter maintenance purposes, will be exempt from

## THE M6 MOTORWAY (JUNCTION 4) AND THE A446 TRUNK ROAD (NEAR LITTLE PACKINGTON) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2019

NOTICE IS HEREBY GIVEN that Highways England Company Limited (Company No. 9346363) has made an Order on the M6 Motorway and the A446 Trunk Road, near Little Packington, in the County of Warwickshire and the Metropolitan Borough of Solihull, for barrier and signage repairs to be carried out.

The effect of the Order will be to close -

- a) the entry slip road leading to the northbound carriageway of the M6 at Junction 4:
- the northbound carriageway of the A446 from its merge with the northbound carriageway of the A452, near Little Packington, to its roundabout junction with the slip roads leading to and from the M6 at Junction 4;
- the link road leading from its roundabout junction with the A452, the B4438 and Solihull Parkway, near Little Packington, to the northbound carriageway of the A446; and
- to the northbound carriageway of the A446; and
  d) the layby situated adjacent to the northbound carriageway of
  the A446 approximately 300 metres south of the centrepoint

of its roundabout junction with the M6 slip roads at Junction 4. The work will be carried out overnight between 21:00 hours and 06:00 hours and is expected to start on Tuesday 5 March 2019 and

continue for two nights. The Order will come into force on 4 March 2019. Vehicles being used for police, fire and rescue authority, ambulance or traffic officer purposes, and vehicles being used in connection
