The Metropolitan Borough of Solihull (A452 Kenilworth Road) (Temporary Road Closure) Order 2019

The Council intends to make the above Order under Sections 14 and 15 of the Road Traffic Regulation Act 1984 (as amended by the Road Traffic (Temporary Restrictions) Act 1991), being satisfied that traffic should be restricted or prohibited to allow river defence, surfacing, barrier and bridge works to be undertaken in safety. **A452 Kenilworth Road (southbound carriageway only)** will be closed from **Stonebridge Island to Cornets End Island** from **0930hrs on Saturday 16th March 2019 to 1600hrs on Sunday 19th May 2019**. Alternative routes for southbound traffic will be signed via southbound A45 Birmingham Road to Pickford Brook Island, northbound A45 Birmingham Road, Maxstoke Lane, B4104 Birmingham Road and B4102 Hampton Lane. Access for emergency services cannot be maintained through the restriction. Pedestrian and vehicle access to all properties within the restriction and access through the restriction will be maintained along defined routes throughout the period of the closure.
