The proposals are:

The Metropolitan Borough of Solihull (Elms Close and The Green, Solihull) (Total Prohibition of Waiting) Order 2019

Proposed Total Prohibition of Waiting – Elms Close, Solihull – on its northern side from a point 15m west of The Green in an easterly direction to a point 15m east of that junction. The Green, Solihull – from Elms Close in a northerly direction to a point 15m north of that junction on both sides of the road.

The Metropolitan Borough of Solihull (Croft Down Road, Elmdon) (No Entry & One Way Traffic) Order 2019

Proposed No Entry – All vehicular traffic – 24 hours/7 days per week – Croft Down Road – no traffic will be permitted to enter Croft Down Road from Valley Road. Proposed One Way Traffic – 24 hours/7 days per week – Croft Down Road – no person shall cause or permit any vehicle to proceed along Croft Down Road in a direction other than northerly, between Victor Road & Valley Road.

The Metropolitan Borough of Solihull (Haslucks Green Road, Shirley) (Restriction of Waiting) Order 2019

Proposed Restriction of Waiting (Monday to Friday 8.00am - 9.30am and 2.30pm - 4.00pm) – Haslucks Green Road, Shirley – on its southern side from a point 50m south west of Cadet Drive in a south westerly direction to a point 100m south west of that junction.

The Metropolitan Borough of Solihull (B4101 Kenilworth Road, Knowle) (Total Prohibition of Waiting) Order 2019

Proposed Total Prohibition of Waiting – B4101 Kenilworth Road, Knowle – on its southern side from a point 205m west of Elvers Green Lane in a westerly direction to a point 250m west of that junction.

The Metropolitan Borough of Solihull (Footpath SL78 and SL79 – Blythe Valley, Shirley) (Temporary Footpath Closure) Order 2019

The Council gives notice that it intends to make the above Order under Sections 14 and 15 of the Road Traffic Regulation Act 1984 (as amended by the Road Traffic (Temporary Restrictions) Act 1991), being satisfied that pedestrian traffic should be restricted or prohibited to allow spine road construction works to be undertaken in safety. **Footpaths SL78 and SL79** (Blythe Valley, Shirley) will be closed from **29 March 2019** until **1 September 2019**. Alternative routes for pedestrian traffic will not be signed. Informatory warning signs will be deployed, not less than seven days before any footpath is closed. Access for emergency services will not be maintained at all times. Where applicable, pedestrian access to all properties within the restriction will be maintained along defined routes throughout the period of the closure.
