

ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF FORSHAW HEATH LANE, EARLSWOOD

Warwickshire County Council proposes to make a Temporary Traffic Order closing Forshaw Heath Lane, Earlswood from a point approximately 40 metres from the entry/exit of M42 junction and for a distance of 90 metres in a northerly direction, to vehicular traffic. The closure is required to facilitate works in connection with the M42 improvement scheme, realignment and resurfacing at the mouth of the junction and installation of street lighting columns.

The Order will commence on 23 April 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 21 October 2019.

PLEASE NOTE: The road will not be closed for the entire period but will be intermittent between the dates above as indicated by signage.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Poolhead Lane, Broad Lane, Alcester Road, Beoley Lane, Penn Lane, A435 M42 J3 Roundabout (and vice versa).

TEMPORARY CLOSURE OF CHURCH LANE, LAPWORTH

Warwickshire County Council proposes to make a Temporary Traffic Order closing Church Lane, Lapworth to vehicular traffic. The closure is required to facilitate works for a new clean water connection.

The Order will commence on 24 April 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 26 April 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Church Lane, Old Warwick Road, Wharf Lane, Spring Lane (and vice versa).

TEMPORARY CLOSURE OF LAPWORTH STREET, LAPWORTH

Warwickshire County Council has made a Temporary Traffic Order closing Lapworth Street, Lapworth, from a point outside Catesby Farmhouse, to vehicular traffic. The closure is required to facilitate works on a water pipe.

The Order will commence 13 April 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 14 April 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Lapworth Street, Old Warwick Road, Catesby Lane (and vice versa).
