The Metropolitan Borough of Solihull (Salter Street, Earlswood) (Temporary Road Closure) Order 2019

The Council gives notice that it intends to make the above Order under Sections 14 and 15 of the Road Traffic Regulation Act 1984 (as amended by the Road Traffic (Temporary Restrictions) Act 1991), being satisfied that traffic should be restricted or prohibited to allow water main renewal works to be undertaken in safety.

Salter Street, Earlswood will be closed for a short distance north of its junction with Limekiln Lane from **0900hrs on Tuesday 28th May to 1700hrs on Tuesday 11th June 2019.**

Alternative routes for traffic will be signed via B4102, Umberslade Road and Cut Throat Lane. Vice versa for the other direction.

Informatory warning signs will be deployed, not less than seven days before any particular road will be closed. Access for emergency services will be maintained through the restriction. Pedestrian and vehicle access to all properties within the restriction and access through the restriction will be maintained along defined routes throughout the period of the closure.

The Council gives notice that it has made the above Order under Section 16A of the Road Traffic Regulation Act 1984 and being satisfied that the traffic in the Knowle area and other adjoining local roads, as detailed below, should be restricted or prohibited in the interests of public safety to participants and spectators during the Knowle Fun Run, between 1145hrs to 1400hrs on **Sunday 19th May 2019.
