

ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF PUBLIC BRIDLEWAY SD257X IN THE PARISH OF TANWORTH-IN-ARDEN

Warwickshire County Council has made a Temporary Traffic Order closing Public Bridleway SD257x in the Parish of Tanworth-in-Arden, at grid references: SP15623-70480, to all traffic.

The closure is required to avoid the likelihood of danger to the public because of the dangerous dilapidated condition of a bridge along its route.

The Order will commence on 7 June 2019 and will last for a period of 6 months or until remedial works are completed, whichever is the earlier.

Access to and egress from properties and land situated adjacent to the length of footpath to be closed, if any, will be maintained.

TEMPORARY CLOSURE OF OLD WARWICK ROAD, LAPWORTH

Warwickshire County Council proposes to make a Temporary Traffic Order closing Old Warwick Road, Lapworth from points approximately 20 metres either side of the railway bridge to vehicular traffic. The closure is required to safely facilitate works on and around the railway bridge.

The Order will commence on 24 June 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 27 June 2019. Works will be carried out overnight between 22.00hrs and 05.30hrs.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Old Warwick Road, Shrewley Common, The Cumsey, Lye Green Road, The Green, Henley Road, Warwick Road, Whitley Hill, Blackford Hill, High Street, Birmingham Road, Liveridge Hill, Stratford Road, Stratford Road Aylesbury Road to Boundary (2326-2679), Packwood Lane (and vice versa).

Pedestrian access to and egress from properties and land situated adjacent to the length of roads to be closed will be maintained at all times. Vehicular access will be maintained where possible.
