Proposed Designation of Disabled Parking Bays (Parking Limited to Blue Badge Holders at All Times) – Warwick Road – Dovehouse Parade Service Road – One new marked blue badge holder parking bay located approximately 29m from the entrance to the service road. **Proposed Revocation of existing Limited Waiting Bay – Warwick Road – Dovehouse Parade Service Road** – One marked limited waiting parking bay located approximately 29m from the entrance to the service road.
