The Metropolitan Borough of Solihull (Cornets End Lane, Berkswell) (Temporary Road Closure) Order 2019

The Council gives notice that it has made the above Order under Sections 14 and 15 of the Road Traffic Regulation Act 1984 (as amended by the Road Traffic (Temporary Restrictions) Act 1991), being satisfied that traffic should be restricted or prohibited to allow electricity cable works to be undertaken in safety. **Cornets End Lane** – from outside Western Aggregates Quarry to the Junction with Berkswell Road/Back Lane. **From 0800hrs on Thursday 11th July 2019 to 1700hrs on Friday 2nd August 2019.** Alternative routes for traffic will be signed via Cornets End Lane, Berkswell Road, Main Road and Hampton Lane. The Metropolitan Borough of Solihull (Knowle Wood Road, Dorridge) (Temporary Road Closure) Order 2019
