**The Metropolitan Borough of Solihull (A452 Chester Road, Marston Green – Northbound) (Temporary 50mph Maximum Speed Limit) Order 2019**

The Council gives notice that it intends to make the above Order under Sections 14 and 15 of the Road Traffic Regulation Act 1984 (as amended by the Road Traffic (Temporary Restrictions) Act 1991), being satisfied that traffic should be restricted or prohibited to allow gas main diversion works to be undertaken in safety. Temporary 50mph Maximum Speed Limit from **(12.01am) on Monday 2nd September 2019 to (11.59pm) on Tuesday 2nd March 2021.
