ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF A45 BIRMINGHAM ROAD (LAY BY), GREAT PACKINGTON

Warwickshire County Council has made a Temporary Traffic Order closing A45 Birmingham Road (Lay by), Great Packington, to vehicular traffic. The extent of this closure has now been amended and therefore differs from that as advertised in the Solihull Observer 15 August 2019.

The closure is required for the safety of all road users and of the contractors working on or near to the carriageway.

The Order will commence on 3 September 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 6 September 2019.
