#### **(Temporary One-Way) Order 2019**

The Council gives notice that it has made the above Order under Sections 14 and 15 of the Road Traffic Regulation Act 1984 (as amended by the Road Traffic (Temporary Restrictions) Act 1991), being satisfied that traffic should be restricted or prohibited to allow highway improvement works to be undertaken in safety. **Service road to the rear of 240 to 278 Stratford Road, Shirley, B90 3AE. #### **(Balsall Common Fun Run)**

#### **(Temporary Road Closures) Order 2019**

The Council gives notice that it intends to make the above Order under Section 16A of the Road Traffic Regulation Act 1984 and being satisfied that the traffic in the Balsall Common area and other adjoining local roads, as detailed below, should be restricted or prohibited in the interests of public safety to participants and spectators during the Balsall Common Fun Run, between 1130hrs to 1400hrs on **Sunday 22nd September 2019**.
