The Metropolitan Borough of Solihull (Balsall Common Fun Run) (Temporary Road Closures) Order 2019

The Council gives notice that it has made the above Order under Section 16A of the Road Traffic Regulation Act 1984 and being satisfied that the traffic in the Balsall Common area and other adjoining local roads, as detailed below, should be restricted or prohibited in the interests of public safety to participants and spectators during the Balsall Common Fun Run, between 1130hrs to 1400hrs on **Sunday 22nd September 2019**. The following roads will be closed: **Gypsy Lane** – from the Heart of England School front entrance to Alder Lane. **Holly Lane** – from Alder Lane to Frog Lane. **Frog Lane** – for its entire length. **Balsall Street East** – from Holly Lane to Needlers End Lane. **Needlers End Lane** – for its entire length. **Station Road** – from Needlers End Lane to Kemp Green Road. **Station Road** – from Balsall Street East to Burberry Grove. **Kemps Green Road** – for its entire length. **Asbury Road** – for its entire length and to the rear entrance of Heart of England School. As a result of the event, access will be restricted to frontages only. An alternative route for traffic is not viable due to the nature of the roads in the area. The Metropolitan Borough of Solihull (Whateley Green, Castle Bromwich) (Temporary Road Closure) Order 2019

The Council gives notice that it has made the above Order under Sections 14 and 15 of the Road Traffic Regulation Act 1984 (as amended by the Road Traffic (Temporary Restrictions) Act 1991), being satisfied that traffic should be restricted or prohibited to allow gas main renewal works to be undertaken in safety. **Whateley Green, Castle Bromwich, B36 0AH** – at the junction with Water Orton Road. Road Closure from **8am on Monday 16th September to 5pm on Friday 27th September 2019**. Alternative routes for traffic will be signed via Chester Road and Water Orton Road.
